3. **NOW THEREFORE**, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee, NCTE hereby grants recognition to Pratik College of Education, Plot Nos. - 212, 214, 215, 216, Vill/PO- Thepaha, Tehsil/Taluka- Siwan Sadar, Dist.- Siwan, Bihar – 841245 for conducting B.Ed. programme of two years duration with an intake of 100 (two basic unit) from the academic session 2016-2017 under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

  - Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
  - The affidavit with enclosure submitted along with application;
  - The institution shall be free to post additional relevant information, if it so desires.
