
ORDER

3. **NOW THEREFORE**, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Eastern Regional Committee, NCTE hereby grants recognition to **Pratik College of Education, Plot Nos. - 212, 214, 215, 216, Vill/PO- Thepaha, Tehsil/Taluka- Siwan Sadar, Dist.- Siwan, Bihar - 841245** for conducting **D.El.Ed.** programme of two years duration with an intake of **100 (two basic unit)** from the academic session **2016-2017** under Clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfillment of the following conditions:-

1. The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with account with Regional Director of NCTE should be maintained perpetually. Loan raising against or mortgaging of FDRs shall not be done.

 - h) Number of books in the library, journals subscribed to, and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application;
 - j) The institution shall be free to post additional relevant information, if it so desires.


